Primary Areas of Expertise

- Answers the question: what do people need to know and do for success in various talent development roles?
- Defines the content that is tested on the CPLP certification exams

Secondary Area of Expertise

^{*}ATD CI = The ATD Certification Institute

What's the process?

Earning the CPLP

Eligibility

Minimum of five years industry-related work experience or the equivalent

- Four years full-time work experience in the talent development field plus one year of related education or equivalent
- The successful completion of a qualifying ATD Master Series program counts as one year of education

Awarded after passing

- 150-item Knowledge Exam
- 100-item Skills Application Exam in candidate's choice of TD, ID or MLP

How Achieved


Recertification

Continuing professional development is required to maintain the certification; 60 hours every 3 years

 - Join study groups locally or online



CPLP Pricing

- CPLP Test Fees:
 - ATD Member: \$900 USD
 - ATD Non Member: \$1250 USD
- Retesting & Transfer Fees: \$300 USD
- Prep Programs: \$300 USD and up
- Recertification Fees: \$200 USD




CPLP Return on Investment

Findings show that the CPLP is valuable to both individuals and organizations:

- Contributes to an 11% improvement in the proficiency of the talent development function
- CPLPs report gains in job confidence, work quality, and program effectiveness.
- For every \$1 dollar invested, there is a \$1.62 return. Comparable programs have a 25-50% rate of return.

- Established in 2006 and over 2,000 individuals certified to date
- Geared to advanced talent development professionals
- Our highest certification granted for successful completion of 2 exams:
 - Knowledge Exam validates broad mastery inm10 AOEs.
 Requires 80+ hours of study.
 - Skills Application Exam validates deep mastery of one AOE.
 Requires 40+ hours of study.
- To enter: 5+ years of full-time related work experience or equivalent
- To maintain: 60 professional development credits every 3 years
