Development (APTD) is a certification for talent
development professionals who are in the early
part of their careers or whose professional roles
and aspirations are more broad than only talent
development. A minimum of three (3) years of
professional experience is required. The
knowledge covered in the APTD includes the
foundations of talent development that
professionals can use every day, no matter the
level within an organization or company. It may
be a destination for some or a stepping stone to
the CPTD for others.





## **Application Completion**

- A current resume upload is also required.
- The application is not approved until the certification fee is remitted.
- Complete but not yet paid applications will be invalidated after 6 months
- 10% of all applications will be audited
- Once application is approved, you will receive instructions on scheduling your exam appointment.

# 4. Auditing

## ATD CI has a new Audit Process

- 10% of all applications submitted will be automatically flagged for review
- If your application is flagged, here is what will happen:

Your application is flagged for Audit A member of the ATD CI Team will reach out for your supporting documents

You submit requested documentation

ATD CI will review your information and determine eligibility

All communication will occur in Secure Messaging within the Candidate Portal.

## ATD CI has a new Audit Process



If your documentation checks out and you are eligible for the certification for which you applied, your application will be approved and you may proceed to scheduling your testing appointment.



If your documentation reveals that you are not eligible for the certification for which you applied you have several options:

- Submit additional work experience or professional development activities that bring your qualifications in line with eligibility requirements.
- If you've applied for the CPTD, but are not yet eligible, and you
  ARE eligible for the APTD, you may apply for the APTD.
- If you are not yet eligible, your certification fee will be returned, minus \$250, and you may reapply when you are eligible.



CPTD Pilot of August 5-25 will be the only available window to schedule. Additional dates will be available late 2Q/early 3Q.

APTD windows will extend into 2021 with the first window set being July-September 2020.
